OHSAS 18001 : 2007



OHSAS 18001:2007 is the international specification for an Occupational Health & Safety management system (OH&S). It specifies requirements for establishing a health and safety policy, determining risks and hazards of products/activities/services, planning objectives and measurable targets, implementation and operation of programs to meet objectives and targets, with continual improvement through corrective action and management review.



ISO 9001:2008 & ISO 9001:2015-Certified

ISO 9001:2008 is a family of standards and guidelines for quality in the manufacturing and service industries from the International Organization for Standardization (ISO). ISO certification ensures that the processes that develop the product are documented and performed in a quality manner.

ISO 9001:2015 is the most comprehensive level of the ISO 9000:2000 series, covering everything from design and development through production and distribution of products and services. The overall objective is to establish a system to improve product quality and reliability.



ISO 14001:2004 & ISO 14001:2015-Certified

They specify requirements for establishing an environmental policy, determining environmental aspects and impacts of products/activities/services, planning environmental objectives and measurable targets, implementation and operation of programs to meet objectives and targets, checking and corrective action and management review.



STMC

STMC stands for the Standardized Test Methods Committee. The International Imaging Technology Council (Int'l ITC) administers the STMC program, assures its proper usage and polices against misuse of the STMC program and logos. For more than a decade, the STMC symbol has been the remanufacturing industry's indicia of quality. The test methods are used to evaluate toner printer cartridge performance. STMC uses certain ASTM test methods to evaluate a finished cartridge in comparison to another cartridge, typically an OEM cartridge.



EPA WasteWise Partner

WasteWise is the country's first national voluntary solid waste reduction program. WasteWise encourages organizations to reduce municipal solid waste through waste prevention, recycling, and buying or manufacturing recycled

products. Through this partnership, WPP has established the goal to reduce its waste generation by 10-percent in one year.



Sustainable Forestry Initiative®

All vendors providing final exterior packaging for WPP finished inkjet and laser cartridges are certified by the SFI program, which is based on the premise that responsible environmental behavior and sound business decisions can co-exist. Each of these partners has been SFI-certified to practice sustainable forestry on all lands it manages.



EcoLogo CCD-039

WPP maintains toner cartridge offerings that are EcoLogo Certified under the CCD-039 Printing Cartridge standard. This standard takes a multi-parameter approach, identifying important environmental indicators at all stages of a product's lifecycle as well as product performance criteria. EcoLogo is a third-party eco-labeling program approved by the Global Ecolabelling Network as meeting the ISO 14024 standard. EcoLogo one of the most recognizable eco-labels in North America.



R2 Certification

R2 Certification, also known as Responsible Recycling Certification, provides verification of Clover Imaging Group's environmentally responsible, safe, and transparent management of toner cartridges, cell phones, and other consumer electronics.
